THIS AGREEMENT, made this SEP 02 2022 day of SEP 02 2022 between the **SCHOOLS DIVISION OF ILOCOS NORTE** duly represented by the **JOANN A. CORPUZ EdD, CESO V**, Schools Division Superintendent (hereinafter called "the Owner") as the Party of the First Part and **Joshua and Caleb Gen. Mdse.** represented by **GLORIA A.   - f. Addenda and/or supplemental/Bid Bulletins, if any;
  - g. Bid form including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
  - h. Eligibility requirements, documents and/or statements;
  - i. Performance Security;
  - j. Credit line issued by a licensed bank, if any;
  - k. Notice of Award of Contract and the Bidder's conforme thereto;
  - l. Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the contractor as hereinafter mentioned, the contractor hereby covenants with the Entity to execute and complete the works within **Thirty (30) calendar days** and remedy any defects therein
