WHEREAS, the Bids and Awards Committee (BAC) through its BAC Secretariat posted/published the Invitation to Bid through the Philippine Government Electronic Procurement System (PhilGEPS) for the project: **PB-16-2023 Procurement of Materials for the Production of Modules, Lot 5** - Printing Materials for Elementary with an Approved Budget for the Contract (ABC) of **Two Million Four Hundred Two Thousand Eight Hundred Pesos (Php 2,402,800.00)**;

WHEREAS, in response to the advertisement, five (5) prospective bidders; **JOSHUA AND CALEB GENERAL MERCHANDISE, BEAU ESSENCE, PROVERBS ENTERPRISES, KSD MERCHANDISING CORPORATION (LAOAG NEW INDIA DEPT. STORE), AND MASANGKAY COMPUTER CENTER** have purchased and submitted their bid documents before the deadline of posting;

WHEREAS, upon opening of bids and thorough evaluation of the eligibility requirements that have been submitted/presented by each aforementioned bidder, all bidders have passed the eligibility criteria and the BAC declared **KSD MERCHANDISING CORPORATION** as the Lowest Calculated Bidder;

WHEREAS, through the approval of the Head of Procuring Entity, the said project was awarded to **KSD MERCHANDISING CORPORATION** after completion of all procurement processes as mandated under the Updated 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184;

WHEREAS, as per Section 37.4.2 of the said mandate, *“a copy of the Notice to Proceed (NTP) and the approved Contract shall be posted at PhilGEPS through the BAC Secretariat”*, thus, these documents have been posted on the said website;

WHEREAS, however, upon careful review after the posting of the said documents at PhilGEPS, it was found out that the project was mistakenly awarded to **FASTLINE TRADING INC.** instead of **KSD MERCHANDISING CORPORATION**;

WHEREAS, however, in all procurement documents including the Notice of Award (NOA), Notice to Proceed (NTP) and the Approved Contract, the said project was awarded to **KSD MERCHANDISING CORPORATION**;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED;

- a) To recommend for the consideration and acceptance of the PhilGEPS award posting;
- b) To post this Resolution to the Bulletin Board and on the Procuring Entity’s official website.
