# A RESOLUTION RECOMMENDING THE USE OF REPEAT ORDER AS AN ALTERNATIVE METHOD OF PROCUREMENT OF

#### DISASTER PREPAREDNESS, SAFETY, AND EMERGENCY SUPPLIES AND EQUIPMENT (Lot 2)

#### OF THE SCHOOLS DIVISION OF ILOCOS NORTE

WHEREAS, the Administrative Officer IV (Supply) of DepED SDO of Ilocos Norte submitted the Purchase Request for

### DISASTER PREPAREDNESS, SAFETY, AND EMERGENCY SUPPLIES AND EQUIPMENT (Lot 2)

WHEREAS, the said PURCHASE REQUEST was duly approved by the Schools Division Superintendent.

WHEREAS, Republic Act No. 9184, Implementing Rules and Regulations of RA 9184, and other pertinent Rules and Regulations in Government Procurements provides Repeat Order as an Alternative Method of Procurement.

WHEREAS, the BAC of SDO of Ilocos Norte resorted to Repeat Order as an alternative method due to the following reasons:

- 1. The procurement does **NOT** include commonly-used supplies available in the DBM-PS.
- 2. The procurement does not result to splitting; and
- 3. Considering the timeliness and practicality of the procurement.
- 4. That the purchase of additional similar items where savings from the previous procurement activity through public bidding be utilized.
- 5. That after conducted canvass/market research on similar items and found out that prices offered during the previous procurement activity by the same supplier is more economical that the existing/current prices of the same. Thus, resorting to Repeat Order is very much advantageous to the government.

NOW THEREFORE, be it resolved as it is hereby resolve to recommend to the Schools Division Superintendent the use of REPEAT ORDER as an Alternative Method of Procurement of

### DISASTER PREPAREDNESS, SAFETY, AND EMERGENCY SUPPLIES AND EQUIPMENT (Lot 2)

Resolved further, to instruct the BAC Secretariat to do the following:

- \* To see to it that the goods were procured under a contract previously awarded through competitive bidding;
- To see to it that it shall not exceed twenty five percent (25%) of the quantity of each item in the original contract: and
