THIS AGREEMENT, made this SEP 12 2025 day of _____ between the **SCHOOLS DIVISION OF ILOCOS NORTE** duly represented by the **Atty. DONATO D. BALDERAS, JR.**, Schools Division Superintendent (hereinafter called “the Owner”) as the Party of the First Part and **Providers Multi-Purpose Cooperative** represented by **EMELYN G. LIBAN** of 1 AH26, Magsaysay, Naguilian, Isabela (hereinafter called “the Contractor”) as the Party of the Second Part.

 - i. Performance Security;
 - j. Credit line issued by a licensed bank, if any;
 - k. Notice of Award of Contract and the Bidder’s conforme thereto;
 - l. Other contract documents that may be required by existing laws and/or the Entity.

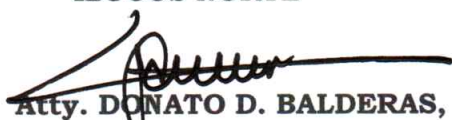
The payment schedule is subject to the usual time allotted for the financial processing, disbursement requirements, and mode of disbursement for government transactions.

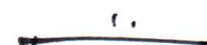

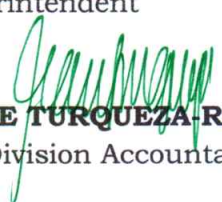
