RESOLUTION AUTHORIZING THE CORRECTION OF A TYPOGRAPHICAL ERROR IN THE AWARDED AMOUNT POSTED IN THE PHILIPPINE GOVERNMENT ELECTRONIC PROCUREMENT SYSTEM (PHILGEPS) FOR PB-01-2026-Lot 4

WHEREAS, the Schools Division of Ilocos Norte - Bids and Awards Committee advertised the Invitation to Bid for **PB-01-2026 Procurement of CY 2026 Learning Continuity Spaces (LCS) Batch 1-Lot 4** with an Approved Budget for the Contract of **Ten Million Seven Hundred Thirty Four Thousand Three Hundred (Php 10,734,300.00)** at its official website and posted the same in the PHILGEPS;

WHEREAS, in response to the advertisement, only one (1) prospective bidder, **ELOCIN Construction**, purchased and submitted its bid documents and was declared "Passed" after the evaluation of the eligibility documents presented in the Bid Opening;

WHEREAS, through the approval of the Head of Procuring Entity, the aforementioned project was awarded to ELOCIN Construction after completion of all procurement processes as mandated under the Implementing Rules and Regulations of RA 12009;

WHEREAS, upon post-award verification, it was discovered that the awarded amount posted in the Philippine Government Electronic Procurement System (PhilGEPS) contains an erroneous amount of **Ten Million Six Hundred Nineteen Thousand One Hundred Thirty Eight and 18/100 (Php 10,619,138.18)** instead of **Ten Million Six Hundred Nineteen Thousand One Hundred Thirty Nine and 18/100.00 (Php 10,619,139.18)**.

WHEREAS, the said discrepancy is a purely clerical or typographical error and does not affect the scope of work, technical specifications, winning supplier, or the result of the procurement process;

WHEREAS, there is a need to correct the PhilGEPS posting to ensure the accuracy, consistency, and transparency of procurement records, in compliance with Republic Act No.12009 and its Implementing Rules and Regulations;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**, to authorize the correction of the typographical error in the awarded amount posted in PhilGEPS for PB-01-2026 Procurement of CY 2026 Learning Continuity Spaces (LCS) Batch 1-Lot 4 from Php 10,619,138.18 to Php 10,619,139.18;

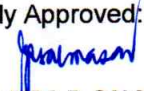

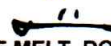
