BID-OPENING: September 15, 2020


The Opening of Bids for the project: *PB-005-2020-Provision of Learning Resources (LRs) for the Implementation of the Basic Education-Learning Curriculum Plan* was conducted on September 15, 2020 and No Bidder submitted a Bid Proposal, therefore the Chairman of the Bids and Awards Committee (BAC) declared for a *Failure of Bidding* for the said project.

As per observation, no bidder was able to submit their Bid Proposals and attend the bid opening for the following reasons:

1. Considering the given items in the project in this COVID-19 pandemic situation, they cannot deliver the goods/supplies within 10 days upon the signing of the Notice of Award/Purchase Order;
2. Considering also the given Approved Budget of Contract (P37,415,685.87), it is difficult for them to present a Single Largest Completed Contract (SLCC) which is the 50% of the ABC that is at least P 18,707,842.94.
